**RENTAL PERMIT NOTICE**

Dear Property Owner:

All owners who plan to rent their property must obtain a rental permit. Please note the new rental year runs **May 1<sup>st</sup> to April 30<sup>th</sup>**. To receive a discount on your renewal, your **completed** application packet must be received by **April 30<sup>th</sup>**. The following are required for an application to be deemed complete:

- Application (see back) with all sections filled in and signed by the owner.
- Payment for your total fee (see 1 and 2 below)
- A signed fire inspection form (see 3 below)
- A certificate of insurance showing \$500,000 liability policy covering the property as required by the State of New Jersey for all businesses, including rentals
- Borough Tax and Water/Sewer accounts must be current as of application date

Before applying:

1. The rental permit fee is \$200 per unit until April 30<sup>th</sup> then increases to \$300 (fees include \$50 fire inspection fee).
2. Multiple Dwelling/Retreat Lodging facilities pay the base fee above for each of the first 3 units plus an additional \$65 per unit over three (includes \$50 rental fee and \$15 fire inspection fee).
3. Call (609) 884-8468 ext. 21 to schedule your rental fire inspection with Brady Schoenrock; schedule early in the spring to be sure you can submit your application by the April 30<sup>th</sup> deadline. To pass inspection the property must have:
  - smoke detectors in good working order within 10' of sleeping rooms; they must be hard wired or have a 10-year sealed battery
  - CO detectors when fossil fuel is used
  - 10 lb. fire extinguisher with min. rating of 2A:10BC – either new or with satisfactory annual inspection
