- Lake Lily Discussed communication and relationship with Friends of Lake Lily (FoLL). Borough solicitor's advice is for the EC to work with the commissioner in charge of Public Lands. At next month's meeting, RM requested that the EC review all proposals concerning Lake Lily.
- Triangle Park Nothing new. See Facebook On Cape May Point for post by NJAS.
- **Beach** The replenishment project will start soon. The sand will be trucked from Coast Guard base and the South Cape May Meadows.
- **Green Team** All materials were submitted by the final deadline and our application is now complete. The borough is now at Bronze status for 3 years. Monthly meetings will occur in the Spring and the Fall. For now, it will be a monitoring effort. CB will no longer chair the Green Team because she has been elected one of the commissioners. CB proposed the incorporation of the Green Team into the EC. This is allowed by Sustainable Jersey. This is what West Cape May has adopted. IN, EO, BB, SA, PM, RM all agreed.
- Commissioner Liaison (RM) The budget process has started now for January/February 2021 approval. The EC will be able to review. One item is the procurement of strong trees for the dunes. These will help reduce blowing sand and provide protection. Suggested budget items:

on-going Triangle Park project, brochure for SLF, person to take minutes, bamboo abatement and Tree of Heaven removal on borough property, and rain barrels at Borough Hall.
